(1) 準買家應參閱發展項目售樓說明書，以了解該項目的資料。
Prospective purchasers are advised to refer to the sales brochure for the development for information on the development.

(2) 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條， -
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的5 個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase-

(i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

(3) 實用面積及屬該住宅物業其他指明項目的面積是按《一手住宅物業銷售條例》第8條及附表二第2部的計算得出的。

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 of the Residential Properties (First-hand Sales) Ordinance.

(4) 註：在第(4)段中，『售價』指本價單第二部份中所列之住宅物業的售價，而『成交金額』指臨時買賣合約中訂明的住宅物業的價錢。因應有關的支付條款及 / 或適用的折扣按售價計算得出之價目，皆以進位到最接近的千位數作為成交金額。

Note: In paragraph (4), "Price" means the price of the residential property set out in Part 2 of this price list, and "Transaction Price" means the price of the residential property set out in the preliminary agreement for sale and purchase. The amount obtained after applying the relevant terms of payment and/or applicable discounts on the Price will be rounded up to the nearest thousand to determine the Transaction Price.

(i) 支付條款 Terms of Payment

(A) 120 天現金付款優惠計劃 120-day Cash Payment Plan (照售價減2%) (2% discount from the Price)

(1) 買方須於簽署臨時買賣合約(「臨時合約」)時繳付相等於成交金額5%作為臨時訂金。買方須於簽署臨時合約後5個工作日內簽署買賣合約(「正式合約」)。

The Purchaser(s) shall pay the preliminary deposit equivalent to 5% of the Transaction Price upon signing of the Preliminary Agreement for Sale and Purchase ("PASP"). The Agreement for Sale and Purchase ("ASP") shall be signed by the Purchaser(s) within 5 working days after signing of the PASP.

(2) 買方須於簽署臨時合約後 120 天內付清成交金額 95%作為成交金額之餘款。

95% of the Transaction Price being balance of the Transaction Price shall be paid by the Purchaser(s) within 120 days after signing of the PASP.

(B) 360 天現金付款優惠計劃 360-day Cash Payment Plan (照售價) (the Price)

(1) 買方須於簽署臨時買賣合約(「臨時合約」)時繳付相等於成交金額5%作為臨時訂金。買方須於簽署臨時合約後5個工作日內簽署買賣合約(「正式合約」)。

The Purchaser(s) shall pay the preliminary deposit equivalent to 5% of the Transaction Price upon signing of the Preliminary Agreement for Sale and Purchase ("PASP"). The Agreement for Sale and Purchase ("ASP") shall be signed by the Purchaser(s) within 5 working days after signing of the PASP.

(2) 買方須於簽署臨時合約後 90 天內再付成交金額 5%作為加付訂金。

5% of the Transaction Price being further deposit shall be paid by the Purchaser(s) within 90 days after signing of the PASP.

(3) 買方須於簽署臨時合約後 360 天內付清成交金額 90%作為成交金額之餘款。

90% of the Transaction Price being balance of the Transaction Price shall be paid by the Purchaser(s) within 360 days after signing of the PASP.

(c) **「活化西九」優惠 “Revitalized West Kowloon” Benefit**

簽署臨時合約購買本價單中所列之住宅物業，可獲額外4%售價折扣優惠。
An extra 4% discount on the Price would be offered to a purchaser(s) who signs the PASP to purchase a residential property listed in this price list.

(d) **復活節慶限時優惠 Happy Easter Time Limited Discount**

凡於2023年5月31日或之前簽署臨時合約購買本價單中所列之住宅物業，可獲額外3%售價折扣優惠。
An extra 3% discount on the Price would be offered to a purchaser(s) who signs the PASP to purchase a residential property listed in this price list on or before 31st May 2023.

(e) **特選星級單位折扣 Supreme Selective Units Discount**

(f) **2023印花稅津貼折扣 2023 Stamp Duty Subsidy Discount**

簽署臨時合約購買本價單中所列之住宅物業，可獲額外3%售價折扣優惠。
An extra 3% discount on the Price would be offered to a purchaser(s) who signs the PASP to purchase a residential property listed in this price list.

(iv) **誰人負責支付買賣該項目中的指明住宅物業的有關律師費及印花稅 Who is liable to pay the solicitors' fees and stamp duty in connection with the sale and purchase of a specified residential property in the development**

- (a) 如買方選用賣方代表律師處理買賣合約、按揭及轉讓契，賣方同意支付買賣合約及轉讓契兩項法律文件之律師費用。如買方選擇另聘代表律師處理買賣合約、按揭及轉讓契，買方及賣方須各自負責有關買賣合約及轉讓契兩項法律文件之律師費用。
If the Purchaser appoints the Vendor's solicitors to handle the agreement for sale and purchase, mortgage and assignment, the Vendor agrees to bear the legal cost of the agreement for sale and purchase and the assignment. If the Purchaser chooses to instruct his own solicitors to handle the agreement for sale and purchase, mortgage or assignment, each of the Vendor and Purchaser shall pay his own solicitors' legal fees in respect of the agreement for sale and purchase and the assignment.
