If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase - (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

If the Purchaser has any objection or requisitions whatsoever in respect of the Furniture Package, the Purchaser shall contact designated furniture company directly. The Vendor in any event shall not be held responsible for any claims, demands, liabilities or losses directly or indirectly incurred in connection with or in relation to this benefit and/or the Furniture Package. In the event of any dispute of this benefit and/or the Furniture Package, the decision of the Vendor and the designated furniture company shall be final.
