If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

The Vendor in any event shall not be held responsible for any claims, demands, liabilities or losses directly or indirectly incurred in connection with or in relation to this benefit and/or the Furniture Package. In the event of any dispute of this benefit and/or the Furniture Package, the decision of the Vendor and the designated furniture company shall be final.

(iv) 誰人負責支付買賣該項目中的指明住宅物業的有關律師費及印花稅 Who is liable to pay the solicitors' fees and stamp duty in connection with the sale and purchase of a specified residential property in the development
