For the safety of prospective purchasers and maintenance of order at the Sales Office or for compliance with the restriction or order relating to Coronavirus Disease 2019 (“COVID-19”), the Vendor reserves its absolute right to, in the case where a Typhoon Signal No. 8 or above or Black Rainstorm Warning is in effect in Hong Kong or where the Vendor considers that there being any event or circumstance affecting or which may affect the safety, order or public health in the Sales Office and/or its vicinity or the Hong Kong Government has imposed any restriction or issued any order relating to COVID-19 and is enforcing the same which requires people in Hong Kong (except for exempted persons) to stay indoor (such as stay-at-home, movement control or lockdown order), postpone or modify the date, time or place of sale to such other date, time or place as the Vendor may consider appropriate. Details will be announced on the website of the Development and persons interested in purchasing the specified residential properties will not be separately notified of the same. The Vendor reserves the right to reject the entry of any person into the Sales Office. The Vendor's decision in this regard shall be final and binding on all persons.
